This information is made available in order to benefit those of you working with children and youth so that you are aware of resources for referral within our community.

Temporary Shelter Services- Youth In Need was funded to expand services to runaway youth. Additional youth will be served at their St. Charles shelter with the hopes of adding a facility in the western portion of our County.

Services to Unwed and Teenage Mothers and Mothers-to-be- Youth In Need was awarded funding to provide support to pregnant teens so they could have healthy pregnancies and births, with parenting support afterwards.

Outpatient Psychiatric Services- Crider Center for Mental Health and Catholic Family Services was given funding to expand their psychiatric services to youth.

Outpatient Substance Abuse Treatment Services- Preferred Family Healthcare and Bridgeway Counseling Services was given funding for outpatient treatment of drug and alcohol. Preferred Family will be opening a 2nd facility in the western portion of the County and Bridgeway will open their facility in St. Charles.

Crisis Intervention Services- Catholic Family Services will expand crisis intervention service hours in the parochial schools.

Transitional Living Services- Youth in Need will expand services to homeless teens, helping them complete their education, learn living skills and find employment.

School-based Prevention Services- Crider Center for Mental Health was given funding to provide an anti-violence and bullying curriculum in the public schools. Preferred Family Healthcare was funded to provide an antidrug curriculum in 3 school districts and the Child Center was awarded funding to provide sexual abuse prevention in the public and private schools. Catholic Family Services was awarded funding to provide antiviolence prevention in the parochial schools.

Home-based Family Intervention Services- The Partnership with Families program was continued, provided by both the Crider Center for Mental Health and FACT.

Counseling Services- Youth In Need and Lutheran Family & Children's Services were awarded funds to expand counseling services at their agencies.
